Sir/Madam,

In continuation to the MARBISM letter of **even no. dated 16.09.2025**, "as per the Regulation no. 04 of Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda, Regulations, 2024 published on 01st October, 2024 there shall be 18 Postgraduate programs in Ayurveda on and from the date of publication of the said Regulations shalakyta Tantra Postgraduate program has been divided into Shalakyta- Netra Roga Chikitsa (Ayurveda Ophthalmology) & Shalakyta- Karna, Naasa and Mukha Raga Chikitsa (Ayurveda Oto-Rhino Laryngology)" and same was informed to you vide letter Ref. No.-3/2025/MARB/General Matters dated 10.06.2025.

In response of the same you have sent an email dated 14.08.2025 in which for 05 seats of Shalakyta Tantra you have opted for Shalakyta-Netra Roga Chikitsa-03 seats and Shalakyta- Karna, Mukha & Nasa Roga-02 seats.

Therefore, the seats of Shalakyta Tantra (05 seats) mentioned in MARBISM letter of even no. dated 16.09.2025 **may be read as Shalakyta Tantra-05 seats (opted for shalakyta tantra- Netra roga- 03 seats & shalakyta tantra- Karna, Naasa and Mukha Roga- 02 seats).**

Rest of the contents of the letter remains same.
